¹ Since the last publication of this information in October 2019, Rio Tinto's interests in Energy Resources of Australia Ltd (ACN 008 550 865) ('ERA') (which operates the Ranger mine) and the Channar Mining joint venture are no longer managed within the relevant Rio Tinto Product Group or no longer represent a joint venture. For ERA, Rio Tinto holds 86.3% of ERA's shares, with the remaining 13.7% of ERA's shares publicly held and traded on the Australian Securities Exchange. For the Channar Mining joint venture, Rio Tinto's ownership interest in the Channar mine increased from 60% to 100% following conclusion of its joint venture with Sinosteel Corporation, upon reaching planned 290 million tonnes production on 22 October 2020.
